SHIPPED SEMEN BREEDING CONTRACT 2019

This agreement made and entered this _____ day of _____, 20____

1. Mare owner hereby agrees to breed their mare _____ reg # _____ to the stallion **Smoke N Sparks** utilizing cooled shipped semen. Bar Three Stables or Sage Veterinary Services reserves the right to charge for replacement of any equitainer lost, damaged or with missing components, not to exceed \$300.00. **The mare owner is responsible for the cost of returning the equitainer by 2 day express, either FedEx or UPS. Do not ship containers Parcel Post.** A charge of \$5.00 per day will be imposed for containers not returned within seven (7) days from original shipment date.

Please check one box:

- A total service fee of \$2000.00, of which \$500.00 is tended herewith as a booking fee and the balance to be paid, along with any additional charges incurred, prior to shipping of the semen. A \$250.00 fee will be required with each additional shipment sent.
- Wyoming Accredited Broodmare, total fee of \$1500.00, of which \$500.00 is tended herewith as a booking fee and the balance paid, along with any additional charges incurred, prior to shipping of the semen. A \$250.00 fee will be required with each additional shipment sent. Proof of Wyoming Accreditation must accompany contract to be valid for discount.
2. **Sage Veterinary Services will collect stallions every Monday, Wednesday, and Friday.** Sage Veterinary Services **must be notified before 6:00pm MST the night prior to collection to guarantee shipment. Sage Veterinary Services must also be contacted the day of collection for confirmation before 9:00am MST.** No semen warranty or guarantee, express or implied, is given. No guarantee of delivery within a certain time period or the quality of the semen at arrival is given. Approximate month cooled semen will be required is _____.
3. The mare owner represents the mare is healthy and in sound breeding condition and is registered. The mare owner agrees to furnish a copy of the mare's registration papers, shipped semen forms, and other information as Sage Veterinary Services requests. Thoroughbred mares must be registered with the AQHA to register foals.
4. When complete payment is made of \$2000.00 plus all shipping charges, this contract provides for one return breeding, in the succeeding year only, for a mare (or agreed substitute) that fails to produce a live foal to stand and nurse. **Sage Veterinary Services must receive a certification by a licensed veterinarian within 10 days of the occurrence.** Breeding may be satisfied in only the year following the date this contract was entered at the sole option to Sage Veterinary Services by:
1) Shipping semen, or 2) rebreeding to be performed at Sage Veterinary Services.
5. **The mare owner agrees to use the semen shipped solely to breed the designated mare in accordance with the breeding contract and registry rules.**
6. Sage Veterinary Services must be notified within 45 days post insemination of Pregnancy Status.
7. It is further agreed that, within the first year of this contract, should the above named stallion die or become unfit for service, or if my mare should die or become unfit to breed, then this contract shall become null and void, and any money paid as part of the stallion service fee, less the booking fee and any used shipping fees, shall be refunded to the mare owner if mare is not bred before said occurrence(s). If the above named stallion dies or becomes unfit for service, or if my mare should die or become unfit to breed, in the rebreed year of this contract this contract shall be considered fulfilled and all full fees apply.
8. When the mare owner, or authorized representative, signs and returns this contract to Sage Veterinary Services, it will be a binding contract to both parties, subject to the above terms and conditions. This contract is not transferable or assignable. The mare owner/lessee agrees to pay all reasonable attorney fees incurred by Sage Veterinary Services in attempting to collect any outstanding balance. The mare owner irrevocably agrees that the mare owner's sole recourse against Sage Veterinary Services with respect to the performance or non-performance of this breeding contract is a return of the stallion service fee, less the booking fee and any used shipping fees.
9. The breeder's certificate will be issued upon notification that the mare has foaled and all debts have been paid.
