## STALLION FROZEN SEMEN CONTRACT 2020

1. I hereby agree to breed my mare \_\_\_\_\_, reg. # \_\_\_\_\_ to the stallion **Smoke N Sparks** using frozen semen at Sage Veterinary Services in Baggs, WY in the year 2020. I agree to pay: (Please check one box)

- AT SAGE VETERINARY SERVICES:** total service fee of \$2000.00, of which \$500.00 is tended herewith as a booking fee and the balance to be paid, along with any additional charges incurred, prior to picking up of the mare. This entitles the mare owner to one cycle of frozen semen breeding on site. If the mare needs additional cycles, a fee of \$200.00 will be charged to the mare owner per cycle.
- SHIPPED SEMEN:** total service fee of \$2000.00, of which \$500.00 is tended herewith as a booking fee and the balance paid to be paid prior to first shipment. Additional shipments will be billed to the mare owner for a fee of \$300.00/shipment. Shipments can be made Monday through Friday. **Sage Veterinary Services needs to know by 6pm the day before shipment to guarantee shipment. Cancellation must occur before 10am MST the day of shipment** to avoid incurring charges. Sage Veterinary Services reserves the right to charge for replacement of any vapor shipper lost, damaged or with missing components, not to exceed \$1200.00. **A return label for the vapor shipper will be provided in the shipment. If the label is not utilized, the return of the shipper will be the responsibility of the mare owner via FedEx or UPS. Do not ship containers USPS.** A charge of \$30.00 per day will be imposed for containers not returned within five (5) days from original shipment date.
- WYOMING ACCREDITED BROODMARE:** At Sage Vet or Shipped (Please indicate shipped or on farm below), total fee of \$1500.00, of which \$500.00 is tended herewith as a booking fee and the balance paid, along with any additional charges incurred, prior to shipping of the semen. A \$250.00 fee will be required with each additional shipment sent. Proof of Wyoming Accreditation must accompany contract to be valid for discount. 2. **For On Farm Mares:** It is agreeable to check my mare for normal breeding condition and to render any treatment or immunization which may become necessary: the expense of this service to be charged to my account.

Immunizations required prior to arrival at Sage Veterinary Services: Western and Eastern Equine Encephalitis, Tetanus, West Nile Virus, Equine Herpes Virus (EHV-1 and EHV-4), Equine Influenza – If immunization status is unknown, the mare will be vaccinated upon arrival.

3. The mare owner represents the mare is healthy and in sound breeding condition and is registered. The mare owner agrees to furnish a copy of the mare's registration papers, shipped semen forms, and other information as Sage Veterinary Services requests. Thoroughbred mares must be registered with the AQHA to register foals. **The mare owner agrees to use the semen shipped solely to breed the designated mare in accordance with the breeding contract and registry rules.**
4. It is further agreed that if my mare should die or become unfit to breed, then this contract shall become null and void and the service fee paid, less booking fee, shall be refunded. A substitution of mare to fulfill this contract will be at the discretion of the stallion owner. If my mare should die or become unfit to breed, in the rebreed year of this contract this contract shall be considered fulfilled and all full fees apply.
5. It is my understanding that you will not be responsible for accident, sickness, or death to my mare or foal, and that you will exercise your best judgment in supervising and caring for them. I will likewise not be responsible for accident or injury to your stallion or mares.
6. **LIVE FOAL GUARANTEE:**  
Should the mare abort or not have a live foal to stand and nurse, this mare will have a return breeding privilege for the next year breeding season only, providing that a certification by a licensed veterinarian of the abortion or birth of a foal which does not stand and nurse is received within seven (7) days of the occurrence. All re-breeds must pay the chute fee of \$500.00. If the mare owner fails to deliver this mare for rebreeding the following year, then any and all fees paid shall not be refundable and the return privilege for rebreeding is cancelled. Sage Veterinary Service must be notified within 45 days from insemination of pregnancy status.
7. **ON FARM BOARD:** Wet \$ 14 – paddock with shelter, 24 – inside stall Dry \$ 13 – paddock, 24 – inside stall  
The mare will not be released until all charges are paid.
8. The breeder's certificate will be issued upon notification that the mare has foaled and all debts have been paid.
